

We are pleased to present you with our twenty-sixth Annual *Drinking Water Quality Report*. This *Report* is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and to protect our water resources.

#### **SOURCES OF WATER**

All of our water supply is pumped from two deep groundwater wells. Both of the wells are located in Millcreek Township. We have not used surface water from the Gold Stream since 1993.

Last year, we produced just over 38.4 million gallons of water for our 1,041 customers, or approximately 105,300 gallons per day on average. Our drinking water again met all federal and state requirements.

In 2007, the Authority finalized the upgrade of the water distribution system which eliminated all lead piping. Since December 2016, the Authority is debt-free, having made at that time the final payment on the loan taken out for the 2007 water system upgrade and improvement project. Specific activities in 2023 included:

- Monthly board meetings were held.
- Martz Technologies and Co-Stream upgraded the SCADA system.
- Leonard "Lenny" Ontkos retired after 35 years of service to the Newmanstown Water Authority
- A new ruling concerning Lead and Copper is mandated by the Federal Environmental Agency (DEP) and mandates that the municipality must inform DEP of the water service line leading into each home or commercial facility that it serves with water.
- In March of 2023, the EPA released a proposed rule regarding PFAS limits through the National Primary Drinking Water Regulation. PFAS is short for per-and polyfluoroalkyl substances. The PFAS ruling was established to enforce standards for quarterly monitoring of water systems beginning January 2024.

The Authority's website is updated monthly with the meeting agenda and minutes. You can find information on the history of the Authority, the Consumer Confidence Report, Rules and Regulations, how to contact the Authority and choices to pay your bill on-line. You have a choice to pay your water bill through Xpress Pay with a credit card, or through the newly added link through Jonestown Bank and Trust, through your checking or savings account.

# Rates for Residential Meters

Since December 2016, the Authority is debt-free, having made at that time the final payment on the loan taken out the for the 2007 water system upgrade and improvement project.

As reported in previous years' reports, new quarterly charges went into effect September 1, 2019.

#### Notes:

- (1) A customer with a 1/2" service line is assessed the same minimum charge as a customer with a 5/8" service line.
- (2) "Service Line Rates" shall be substituted for "Meter Rates". The Minimum Charge is assessed on the basis of the service line size, not the size of the meter.
- (3) There is a \$1.00 per quarter charge for hydrant maintenance.
- (4) There is a \$2.00 per quarter charge for the PA DEP Safe Drinking Water Annual fee.

# **Know the Health Risks**

All sources of drinking water are subject to potential contamination by constituents that are naturally occurring or man-made. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water which must provide the same protection for public health. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline at 1-800-426-4791 or visiting the EPA Office of Water website at www.epa.gov/OGWDW. MCLs are set at very stringent levels for health effects.

To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline at 1-800-426-4791.

Nitrate in drinking water at levels above 10 ppm is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant you should ask for advice from your health care provider.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with services lines and home plumbing. The Authority is responsible for providing high quality drinking water, but we cannot control the variety of materials used in plumbing

components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.

Sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be
  naturally-occurring or result from urban stormwater runoff, industrial or
  domestic wastewater discharges, oil and gas production, mining, or
  farming.
- Pesticides and herbicides, which may come from a variety of sources, such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.



# Impurities Detected by the Newmanstown Water Authority

The Newmanstown Water Authority routinely monitors for constituents in your drinking water according to federal and state laws. This table shows monitoring results for the period of January 1 to December 31, 2023. The State allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data is from prior years in accordance with the Safe Drinking Water Act.

This table shows <u>only</u> the contaminants that were detected and the levels at which they were detected. There were <u>many</u> other contaminants that were not detected in the samples collected for analysis. Remember that the presence of

certain constituents does not necessarily pose a health risk. All drinking water may be reasonably expected to contain at least small amounts of some constituents.

In 2023, as shown in the Table, our system had no exceedances. We're proud that our drinking water quality meets or exceeds Federal and State requirements. In December 2023, the Chlorine residual was reported incorrectly to the DEP, but that was immediately corrected upon notification from the DEP. In the first quarter of 2023, the required monitoring for Nitrate and Nitrite was not complete, which requires a Public Notice. The Public Notice is included with this Consumer Confidence Report, and the Authority is now in full compliance with the DEP.

1. The Action Level (AL) for Lead and Copper serves as a trigger for water systems to take additional treatmment steps if exceeded in more than 10% of tap water samples. The Action Level for Lead is 15 ug/L, and the Action Level for Copper is 1.3 mg/L. No Action Levels were exceeded in the 2023 sampling.

## **Definitions**

In the tables in this report you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

#### **Action Level (AL)**

The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

#### **MCL - Maximum Contaminant Level**

The "Maximum Allowed" is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

### mg/l - Milligrams per liter or Parts per million (ppm)

One milligram per liter or one part per million (ppm) corresponds to one minute in two years or a single penny in \$10,000.

#### MCLG - Maximum Contaminant Level Goal

The "Goal" is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

#### **MRDL** - Maximum Residual Disinfectant Level

The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

#### MRDLG - Maximum Residual Disinfectant Level Goal

The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.

#### pCi/l - Picocuries per liter

Picocuries per liter is a measure of the radioactivity in water.

#### ug/l - Micrograms per liter

One microgram per liter corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.



## **Source Water Protection**

The Source Water Protection Program, which was approved by the PA DEP in 2009 for our Authority, the Womelsdorf-Robesonia Joint Authority (WRJA) and the Borough of Richland continues to be implemented. **Our goal is to reduce the possibility of contaminants entering our water supply sources.** Protecting our wells is a critical element to delivering a safe and reliable supply of drinking water to our customers. Source water protection not only benefits the water supply, but ultimately the economic, social, and environmental well-being of our community. Several point and nonpoint potential sources of contamination (PSOC) were identified in the preparation of the plan. The Plan found that our sources are potentially most susceptible to agricultural activities, but overall, the Authority's wellhead protection area has a low risk of contamination. The Authority continues to work with the farmers to minimize spreading manure near its well.

## Monitoring Requirements Not Met for Newmanstown Water Authority

Our water system violated several drinking water standards over the past year. Even though these were not emergencies, as our customers, you have a right to know what happened and what we did to correct these situations.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During 1st quarter of 2023 we failed to monitor for the following contaminants and therefore cannot be sure of the quality of our drinking water during that time.

#### What should I do?

# What happened? What was done? When will it be resolved?

The requirement for monitoring Nitrate/Nitrite was changed from Annually to Quarterly in late 2022, however, the Authority's laboratory was not notified of this change. The sampling was still scheduled on an Annual basis, and the required monitoring was not completed in the 1st Quarter of 2023 due to this scheduling error. The error was corrected by the 2nd Quarter of 2023, and the remaining samples were collected accordingly.
